**Contract No. CW-HOU-PBC-RM-02: Performance-based Routine Maintenance of Provincial and District Roads in Houaphan Province**

**Deadline for Bids: 7<sup>th</sup> September 2018** at 14:00 hours (45 days from date of this letter)

1. The Lao People's Democratic Republic has received funding from the World Bank (WB) towards the cost of the Lao Road Sector Project 2 (LRSP2) and it is intended that part of the proceeds of these funds will be used for eligible payments under the above contract. Bidding is open to bidders from eligible source countries of the WB. The eligibility rules of the WB will govern the bidding process.

The project comprises the following contract package:

Bidders wishing to offer discounts will be allowed to do so provided such discounts are included in the Letter of Bid.

2. The Department of Public Works and Transport of Houaphan Province (the Employer) invites sealed bids from eligible bidders for the Works as follows:

(i) Performance-Based Routine Maintenance Services of provincial and district roads, with a total length of 107.80 km, as part of the Provincial and District Road Network located within Houmoueng, Viengthong and Xone Districts, Houaphan Province.

(ii) The number and identification of lots comprising this bidding process is:

- **Lot 1:** Houmoueng District, District Road No. 3507 and Provincial Road No. 3244.
- **Lot 2:** Viengthong District, District Road No. 3209.
- **Lot 3:** Xone District, Provincial Road No. 3204

Bid evaluation and contract award will be on lot basis. The bidders are allowed to bid on any number of Lots.

- (iii) Initial Road Maintenance Works for which a Bill of Quantities is given;
- (iv) A Provisional Sum has been allowed for Emergency Works for which an outline Bill of Quantities is given;
- (v) During the period of the Contract other roads which have been upgraded to Good/Fair condition may be added to the applicable road sections. A Variation to the Contract would be issued to cover payment for any such additional works.
